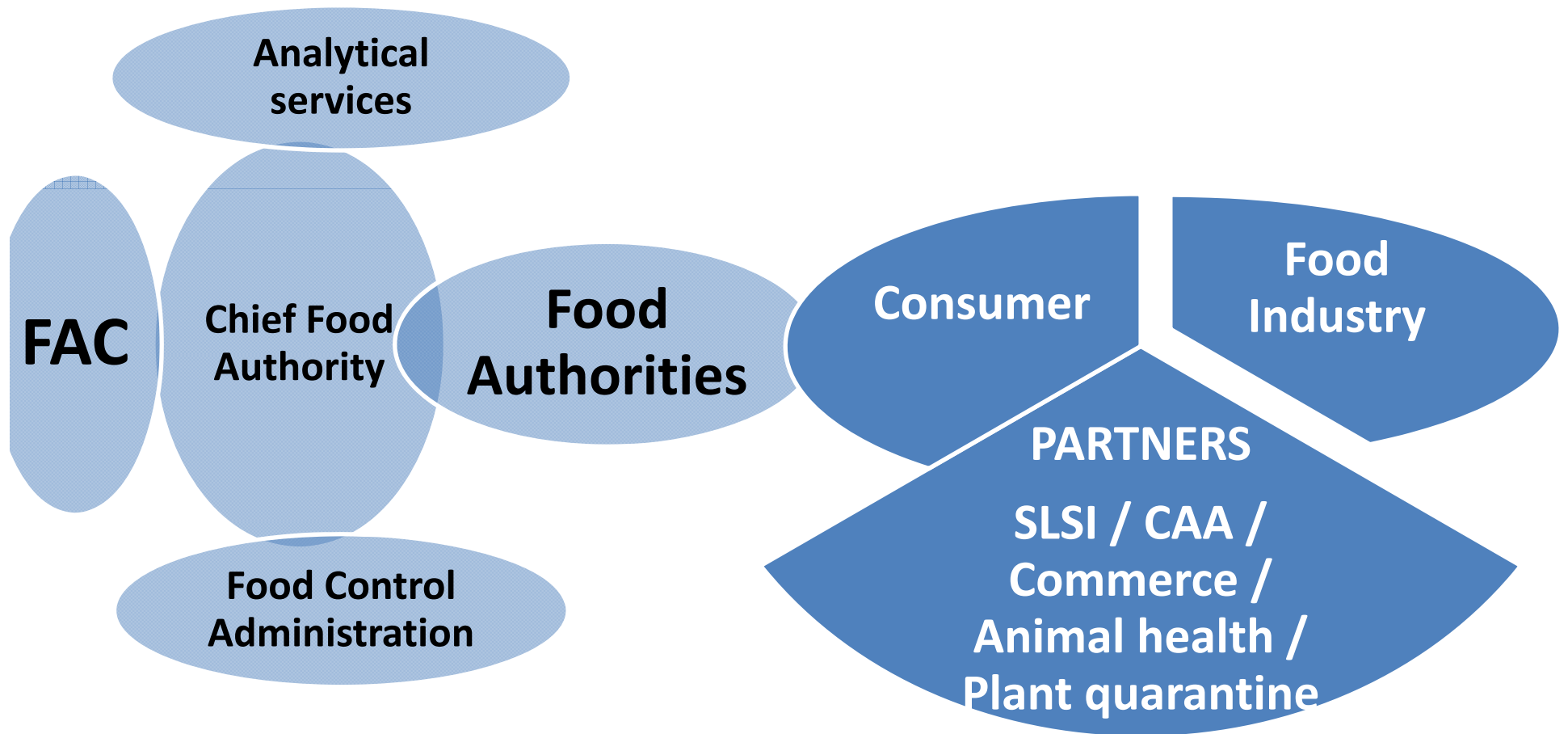

Food borne illnesses

- **Food hygiene – disease prevention**
- **Biological contamination in food causes 70% of diarrhoea globally - Incidence may be 300 to 350 times higher than what is reported**
- **Children (under 5 Years) are most affected from poor quality and unsafe food and water supplies**

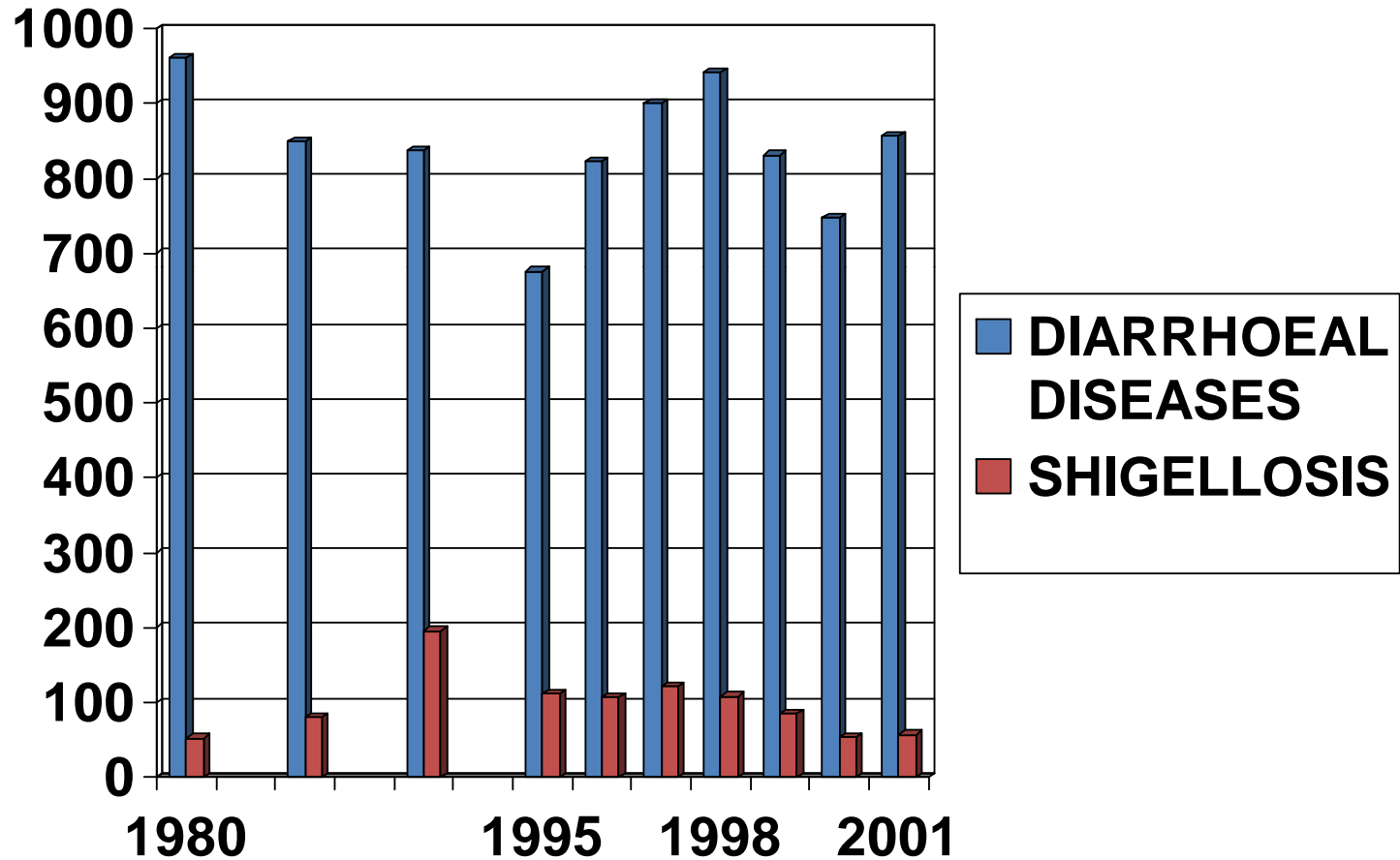
172 food establishments in 04 Districts:

Colombo (MC area excluded), Gampaha, Kalutara, Kurunegala surveyed in April/May 2008.

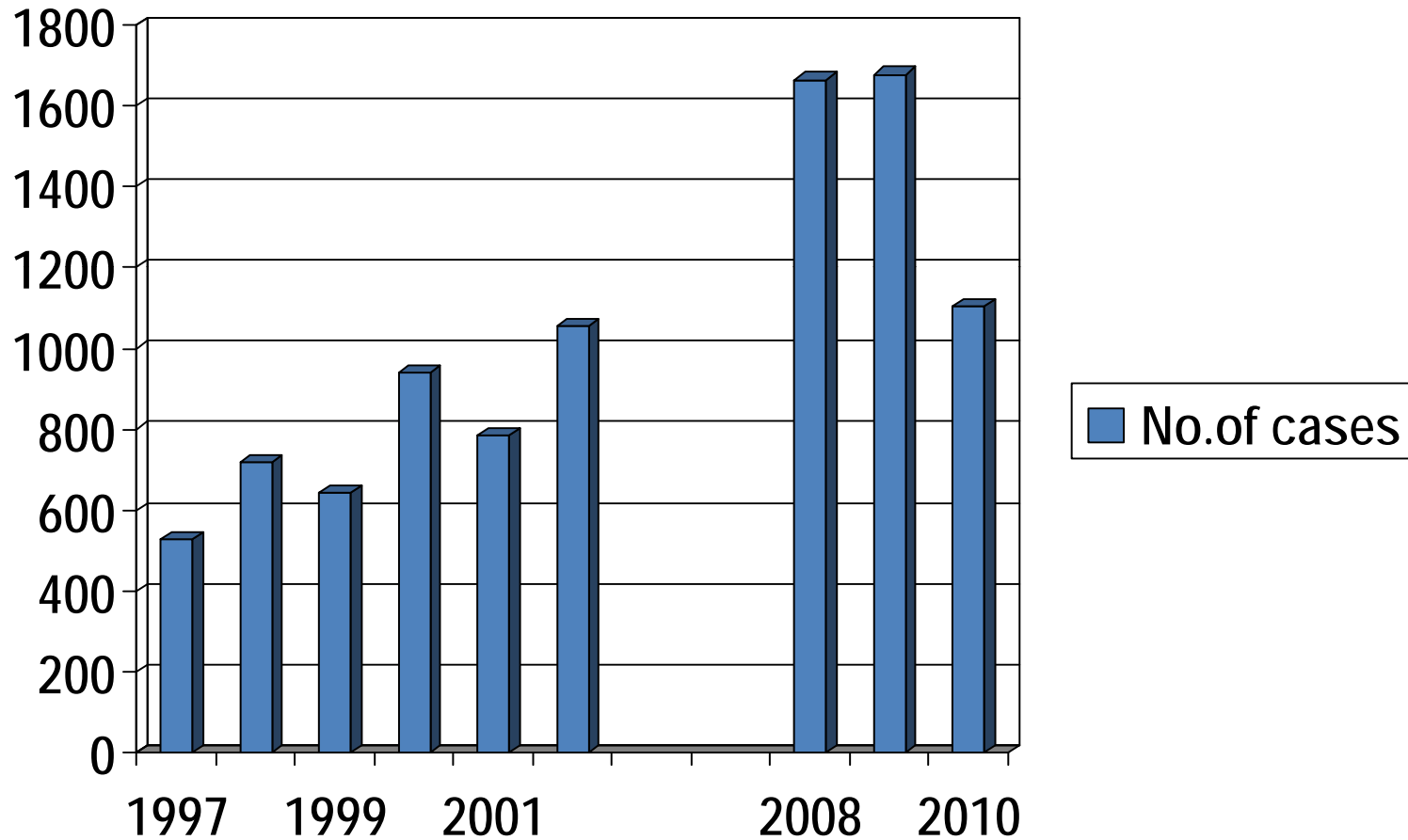
- restaurants (31%), snack bars (24%), tea/coffee shops (37%), and food outlets (8%)**
- 60% of sample in rural areas, 40% urban**
- Food sampling done in previous year: 45% urban, 36% rural**
- Had a H800 rating form: 62% rural, 69% urban**
- Medical checkup: All staff checked: 3% rural, 4% urban**
- All staff trained in food handling: 13% of establishments**

FOOD POISONING (Notifications)



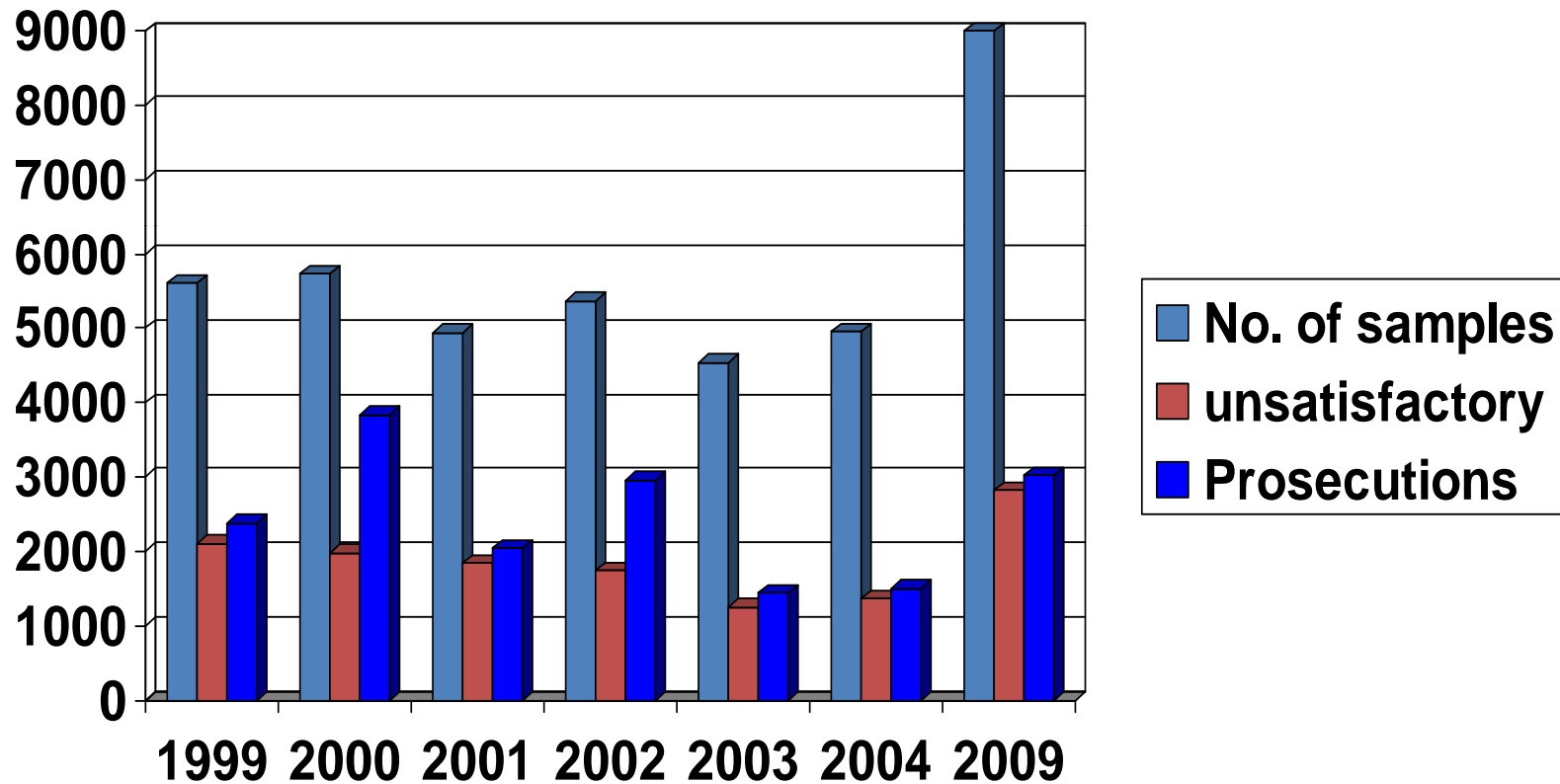
Food and Water borne diseases

- **Bottled water regulations and pipe borne water supply / disinfection**
- **Registration of food handling establishments**
 - **Licensing / training food handlers / medical examination / street vendors**
- **Quality assurance systems – categorization, incentives, traceability, accountability, regulations**
- **Integrate food safety surveillance on food borne / water borne diseases with epidemiological surveillance**
- **Consumer education - Food hygiene - 4 C's**

Surveillance

- **Imported / local foods**
- **Exports –health certificates**

- **Constant updating of standards, regulations, guidelines – bottle necks**
- **Conflict of interests – local Vs imports**
- **Participation in the CODEX process**

- **Awareness and resolution of local issues on exports / imports**
 - **Dept. of Commerce / sister agencies / notification authority and enquiry points under SPS**

Factors affecting new, emerging and reemerging hazards

- **Changes in agricultural production practices**

- **Changes in food production, processing and distribution systems**
- **more ready to eat food products**

Emerging Hazards

- **Environmental pollutants:** Dioxins, PCB's
- **Veterinary drug residues:** Nitrofurans and Chloramphenicol
- **Natural toxins :** Mycotoxins, seafood toxins
- **Toxicants:** Pesticide
- **Metal contaminants:** Mercury, Cadmium
- **Food packaging contaminants:** Vinyl chloride
- **Radiochemicals:** Cs¹³⁷
