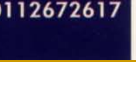

- **Formulation of Sri Lanka Standard Specifications for products and services** - Get national or company standards formulated for your products and services or get the existing standard revised/updated by request.
- **Standardization & Quality related information through library** - (Local & foreign standards, international standards, technical regulations, technical books etc. with computerized searching facilities) Free reference within the library or obtain Membership.
- **Quality Management Training** - (Basic Quality Concepts, 5S, Kaizen, ISO 9001, ISO 14001, Diploma in Quality Management, Food Hygiene & Laboratory Quality Management etc.) Attend scheduled training or obtain in house training specially designed for your company requirements.
- **Product Testing** - (Material, Electrical, Food, Chemical, Textile, Microbiological etc.) Testing against local or foreign standard specifications or your own specifications.
- **Calibration or measuring instruments** - Check whether your instrument gives the correct reading, if not get it corrected.
- **Product Certification** - Products are certified for its conformity to Sri Lanka Standards specifications.
- **Energy Efficiency Labeling for electric appliances** - Convenience your customers that your product is cost effective in energy consumption.
- **Systems Certification** - ISO 9001, ISO 14001, HACCP, ISO 22000, GMP, OHSAS18001, SA8000 Systems Certifications Get your system certified against these standards and show your capabilities to customers.
- **Pre-export inspection of products** - Obtain a certificate for your products for its conformity to standards before you export.
- **Compulsory Import Inspection Scheme** - Approval of consignments of products identified under this scheme.
- **Sri Lanka National Quality Awards** - Apply for the award, get a feedback report and know where you stand, the level of your performance. Name of the applicant will not be disclosed except winners.



## Certification Marks Given By Sri Lanka Standards Institution



This mark on a product or commodity assures that it is consistently manufactured or produced in accordance with the relevant Sri Lanka Standard Specification.



This mark is given by SLSI on energy rating for electrical Appliances, based on a star rated evaluation up to 5 star ( more star means more energy efficient)



This certification is given to organizations that establish, document implement and maintain quality management system in accordance with ISO 9001 standard.



ISO 22000 is food safety management system certification, which demonstrate ability to control food safety hazards in order to ensure that food is safe at the time of consumption.



Hazard Analysis Critical Control Points ( HACCP) is a system, which can be used to assure food safety at all levels of food chain.



ISO 14001 Environmental Management system certification gives scientific guidelines as to how an organization could manage the environmental hazards.



GMP certificate assures that good hygienic practices on handling of foods is continuously practiced by the processor.



Occupational Health & Safety Management System (OHSAS) is a system, which enables on organization to control its occupational Health & Safety risks and improve its performance by minimizing employee related risk issues.



SA 8000 is a global Social Accountability standard for decent working conditions developed based on the conventions of the International Labour Organization, the Universal Declaration of Human Rights as well as United Nation Convention on the Right of a Child.
